Attendance is required Saturday, June 18th, 2022 from 10 AM to 5 PM. NO EARLY TEARDOWNS ARE PERMITTED BEFORE 5 PM. For the safety of all vendors, traffic and the general public, vendors will be expected to comply with committee member and police instruction upon move out. Vendors will also be permitted to set up and sell on Friday evening during the Sock Hop from 5:30 PM to 10 PM (optional). Please be advised that while you may participate in the Sock Hop and leave your booths overnight, there will be minimal security during the show. Police will be regularly patrolling the area on Friday night before the cruise, but doing so is at your own risk. By signing below, I understand that if this application is rejected for any reason, I will be notified and my fees will be returned approx. 30 days of the application deadline. I understand that I will be notified within approx. 10 days upon receipt and acceptance of my application and fee. A notification email will be sent to all participating vendors no later than May 30th, 2022 and will include "move in" instructions, directions and a map. I also understand that ALL vendors MUST be set up by 9:30 AM on June 18th, 2022. There will be separate parking for all vendors. Once accepted, with no exceptions for weather, "NO SHOW" vendor application fees will be non-refundable. This event takes place rain or shine.

All participants agree to indemnify & save harmless Historic Bellefonte Inc, the Historic Bellefonte Cruise, the Historic Bellefonte Committee, Cruise sponsors, the Bellefonte Borough, and the Centre County Government, the owners of any other spaces used for this Marketplace, and their officials & agents against any and all claims, demands, or liability of any kind, including but not limited to theft, personal injuries or property damage directly resulting from acts or omissions of any of the above named organizations in the promotion of show.
